

# PRIVACY POLICY

We are committed to protecting your privacy regarding any information we may collect while operating our website. We will collect and use information through our website only in the ways disclosed in this statement. Trendmarkt Limited sp.k. has no responsibility for content on other websites that you may encounter while navigating this website. Please read on for more details about our privacy policy. This statement applies solely to information collected at the Trendmarkt Limited sp.k. Websites. The policy is effective as of September 15, 2014. Website Visitors Trendmarkt Limited sp.k. collects information from you when you place an order, subscribe to our newsletter or fill out a form. When ordering or registering on our site, as appropriate, you may be asked to enter your: first and last name, e-mail address, mailing address, phone number or credit card information. You may, however, visit our site anonymously. In addition, all videos and photos posted on our website are viewable to the public without restriction. You may also unsubscribe from our communications by clicking on the link or sending an email to [support@ip47.ip-91-121-251.eu](mailto:support@ip47.ip-91-121-251.eu). You can also delete your account at any time.

## GATHERING OF PERSONALLY-IDENTIFYING INFORMATION

---

When you place your order, we need to know your first and last name, e-mail address, mailing address, telephone number. This allows us to process and fulfill your order and to notify you of your order status. When you enter a contest or other promotional feature, we may ask for your name, address, Facebook name and/or e-mail address so we can administer the contest and notify winners. We monitor customer traffic patterns and site usage to help us develop the design and layout of the website. We may also use the information that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Trendmarkt Limited sp.k. also collects potentially personally identifying information like Internet Protocol (IP) addresses. Trendmarkt Limited sp.k. only discloses logged in user IP addresses under the same circumstances that it uses and discloses personally - identifying information as described below, except that IP addresses are visible and disclosed to the administrators of Trendmarkt Limited sp.k. Trendmarkt Limited sp.k. purpose in collecting non personally identifying information is to better understand how Trendmarkt Limited sp.k. visitors use its website. From time to time, Trendmarkt Limited sp.k. may release nonpersonally - identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website. We may also collect personal information to occasionally notify you about important functionality changes to our Website, new products and special offers we think you might find valuable. We may also use your information to personalize your experience and to improve our customer service.

## SECURITY

---

We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information. When you place orders or access your account information, we offer the use of a secure server. The secure server software (SSL) encrypts all information you input before it is sent to us. Furthermore, all of the customer data we collect is protected against unauthorized access. Certain visitors to Trendmarkt Limited sp.k. websites choose to interact with Trendmarkt Limited sp.k. in ways that require Trendmarkt Limited sp.k. to gather personally-identifying information. The amount and type of information that Trendmarkt Limited sp.k. gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a membership at our site to provide a username and email address. Those who engage in transactions with Trendmarkt Limited sp.k., or sign up to open a Trendmarkt Limited sp.k. account, are asked to provide additional information, including as necessary the personal and financial information (name, address, email address, credit card information) required to process those transactions. Trading data, including personal data may be transferred to PayLane Sp. z o.o. with its registered office in Gdansk, street Arkońska 6 / A3, postal code: 80-387, KRS 0000227278 to the extent necessary to support payment for the order. In each case, Trendmarkt Limited sp.k. collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Trendmarkt Limited sp.k. Trendmarkt Limited sp.k. does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

## COOKIES

---

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Trendmarkt Limited sp.k. uses cookies to help Trendmarkt Limited sp.k. identify and track visitors, their usage of Trendmarkt Limited sp.k. website, and their website access preferences.
